1. Clarify which <b>exceptions and special regulations allow for entry</b> (by air, by land, by sea if applicable)	Entry to country is not restricted nevertheless mandatory health screening has been implemented in several ports of entry that may cause significant travel disruption, please consider longer times if you need to travel.
2. Clarify what documents are required (COVID-19 tests, medical certificates, invitation letters, etc.)	No special documentation is requested for COVID contingency. VISA & passport regulations apply normally.
3. Describe self-isolation and government-mandated quarantine requirements;	<p>People is requested to "stay at home" and only people working on "essential activities" (defined by government) are allowed to go to work. Since June 1st, some areas begun the process of lifting restrictions locally using a traffic-light system based on disease transmission rates. Municipalities with higher rates of transmission will be rated as red while those with little or no cases as green. Businesses are required to submit protocols to safety restart of activities that will be subject to approval by the authorities. The wearing of masks or face covers in public is mandatory in certain states and municipalities please consider to bring with you.</p> <p>In HMX facilities following measures are taken and you shall comply:</p> <ul style="list-style-type: none"> <li>* Extended shifts at Workshops and opened sites to minimize number of people working together.</li> <li>* Office Employees rotation between Home and Office to reduce number of Employees in offices.</li> </ul>



	<ul style="list-style-type: none"> <li>* Maintain distance between Colleagues of a minimum of 1.5 m)</li> <li>* Use a mask at all time when walking or working with other Colleagues.</li> <li>* Body check temperature at entry (in case of fever you can not entry the Company and you will be derived to medical revision)</li> <li>* Frequent wash of hands</li> <li>* Use of feet sanitizing station at accesses</li> <li>* Use of sanitizer</li> <li>* Gatherings at same room &lt; 3people</li> </ul> <p>In HMX all people who is coming back from a trip abroad is requested to do a 14 days quarantine at home (or in special cases, due to costs, a COVID-19 test can be performed).</p> <p>So please if you are considering to travel to HMX please get in contact to your host to know if possible, measures can change from one day to another.</p> <p>The next link shows the daily official local State status:  <a href="http://www.michoacancoronavirus.com">www.michoacancoronavirus.com</a></p>
<p>4. Communicate the circumstances by which ANDRITZ travellers can obtain <b>COVID-19 PCR tests</b>, specifically:</p> <ul style="list-style-type: none"> <li>a. Who is eligible for testing;</li> <li>b. Test locations near ANDRITZ offices, project locations, and major international airports; and</li> <li>c. The process for receiving a test and test results.</li> </ul>	<p><b>COVID-19 PCR tests</b> are performed in public &amp; private hospitals but only after other diagnosis are dismissed.</p> <ul style="list-style-type: none"> <li>a. Person who shows symptoms associated with COVID-19 and other diagnosis are previously dismissed.</li> <li>b. Please contact directly Y. González or N. Garibay for a referral.</li> <li>c. Government process for suspicious cases (See above), Private process for preventive tests within 24 hours.</li> </ul>
<p>5. Clarify internal travel limitations/restrictions</p>	<p>Internal travels are not restricted but should be limited or avoided if possible, online meetings &amp; phone calls are recommended.</p>
<p>6. Clarify requirements for leaving country</p>	<p>No restrictions up to now by Mexican Government nevertheless airlines itineraries and return</p>
